#YouSaidWeDid - What matters to you

Your priorities are chosen quarterly and are based upon

information gathered through NHL (Neighbourhood Link), social media, local engagement, and emerging crime trends. You have stated that the following key themes are important to you. #YouSaidWeDid

Priority 1 - Highway obstructions has been raised as a problem. Highway Obstructions including inconsiderate and dangerous parking and vehicle obstructions.

Priority 2 - Motorbikes causing a nuisance has been raised as an issue by residents within the beat area. This causes annoyance for the local community but also poses a risk to local residents and the users of the motorbikes.

Priority 3 - Road Safety has been raised as an issue by local residents in the area. Road Safety including speeding vehicles and vehicles being driven in an anti-social manner.

#WeDid - What we are doing

We will be advising drivers and/or issuing obstruction tickets or seizing vehicles where possible in relation to incidents of vehicles causing an unnecessary obstruction or wilful obstruction of the highway.

We will be issuing traffic offence reports and/or section 59 anti-social behaviour notices to riders committing offences or using their vehicles in an anti-social manner.

We will be utilizing beat surgeries to educate motorists and issue traffic offence reports and section 59 anti-social behaviour notices to drivers committing offences or using their vehicles in an anti-social manner.

PCSO Darby has been out conducting enquiries in relation to a burglary that occurred in Glenfield. It appears Glenfield and the wider area across the Blaby District numerous burglaries have occurred. The method of entry appears to be from the rear of the property so please ensue all doors and windows are locked and consider installing window shock alarms to alert you if anyone attempts to gain access.

Reports were made to us about driving/parking in and around Stafford Leys Primary School, a Sentinel report has been created which is our ASB recording system and an investigation is underway.


